**How To Enter – No Purchase Necessary**

To enter the 2013 Authentic Signed Troy Polamalu #43 Jersey or a signed NFL Football Contest: re-share a Facebook post directly related to the jersey give-away contest. Re-share only one post from the 8 possible posts on Troy's Facebook page ([www.facebook.com/troy43](http://www.facebook.com/troy43)), and 8 possible posts on the FOCUS North America Facebook page ([www.facebook.com/FOCUSNorthAmerica](http://www.facebook.com/FOCUSNorthAmerica)). Only one re-share counts as an entry. You cannot re-share any subsequent posts related to the contest to earn extra entries once you have already re-shared. Please note, to enter by re-sharing, privacy settings must be set so that any third party Facebook user can view your re-share.

**Earn TEN More Entries**

To earn 10 additional entries, text TROY (all uppercase, no spaces) to 52000 and make a one-time \$10 donation to FOCUS North America. Disqualified entries will not be eligible for winning the contest.
